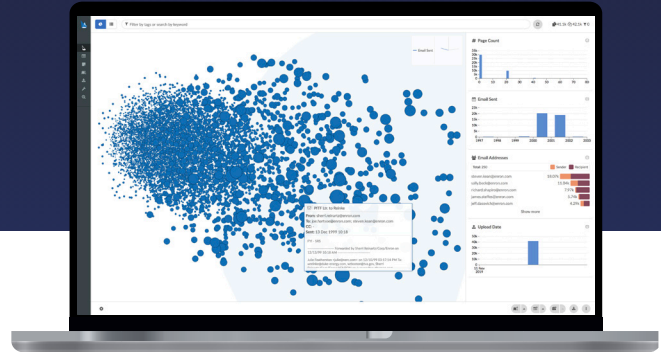

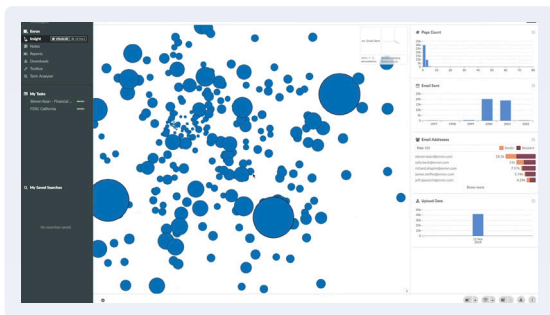

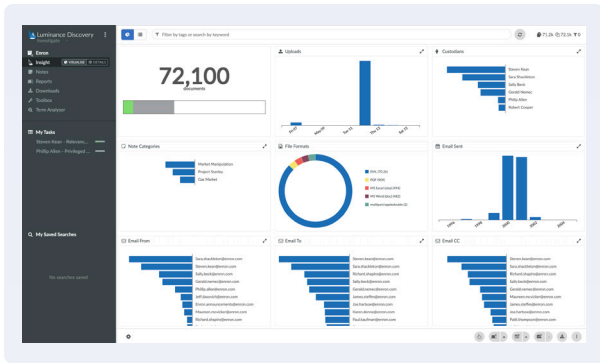
AI Analysis for Rapid Overview of Documents

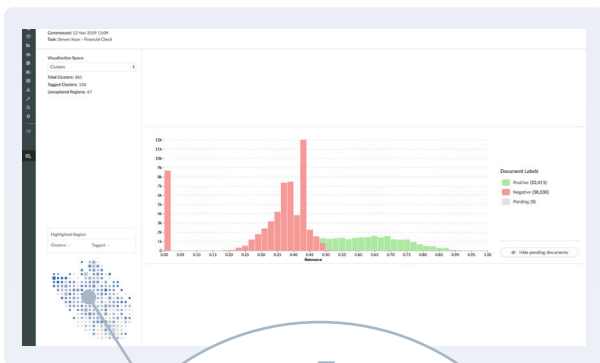

AI-Driven Technology Assisted Review

- Observes the coding actions of the team, flagging where the coding of a document appears anomalous compared to previous coding behaviour and may warrant further review
- Predicts how relevant yet uncoded documents will be, ensuring lawyers can focus their time effectively
- With no prior training needed, Luminance’s heat map organises the entire dataset by conceptual similarity, with each tile representing conceptually-alike documents
- Depth of colour of each tile illustrates how many of these documents have been reviewed, making sure lawyers can allocate resources to under-investigated areas quickly so nothing is overlooked

Use On Documents of Any Language

- Luminance’s advanced pattern recognition technology means that it is language-agnostic

Detects Personally Identifiable Information (PII) and redacts all examples of certain critical and confidential types of information e.g., users could redact all addresses across their entire project
