# Time-Sensitive, High-Volume Document Review



PSL was tasked with an urgent, high-profile arbitration being conducted under the aegis of the Singapore International Arbitration Centre. The preliminary estimate of damages for the claim stood at £38 million and PSL, acting for the claimants, had a team of three lawyers dedicated to the dispute. However, the scale of the review was vast and had to be managed in a timely and efficiently manner; the dataset contained over 750,000 documents in multiple languages. This large dataset needed to be combed through in order to put together their statement of claim. The team decided that it was inefficient go through all of that data manually. By using Luminance, the team completed their investigation in just four weeks, far more efficiently than originally anticipated.

The team was impressed with Luminance's powerful search, filtering and culling capabilities that helped them to quickly find key data in such a large dataset and exclude irrelevant information. The lawyers were aiming to find all documents where the respondents were in breach of the original agreements. The exercise was essentially a factfinding hunt; they had a few people which they knew were relevant to the dispute, they just had to locate the relevant documents.



Due to the timing of the dispute, PSL's team had to go through the documents during the COVID-19 lockdown, and therefore it was of critical importance to the team that technology facilitated remote access to the documents and allowed collaboration between project members. Indeed, Luminance's built-in project management and collaborative tools were a key reason for PSL's adoption of Luminance, with Anant Gupta commenting that, "we wouldn't have done it better if we were physically in the same office."

Using Luminance, PSL was able to gain complete insight into their dataset at speeds that would be simply impossible using manual review processes. PSL estimated if they sat down for 24 hours a day it would have taken four months to complete the project, which they didn't have.
