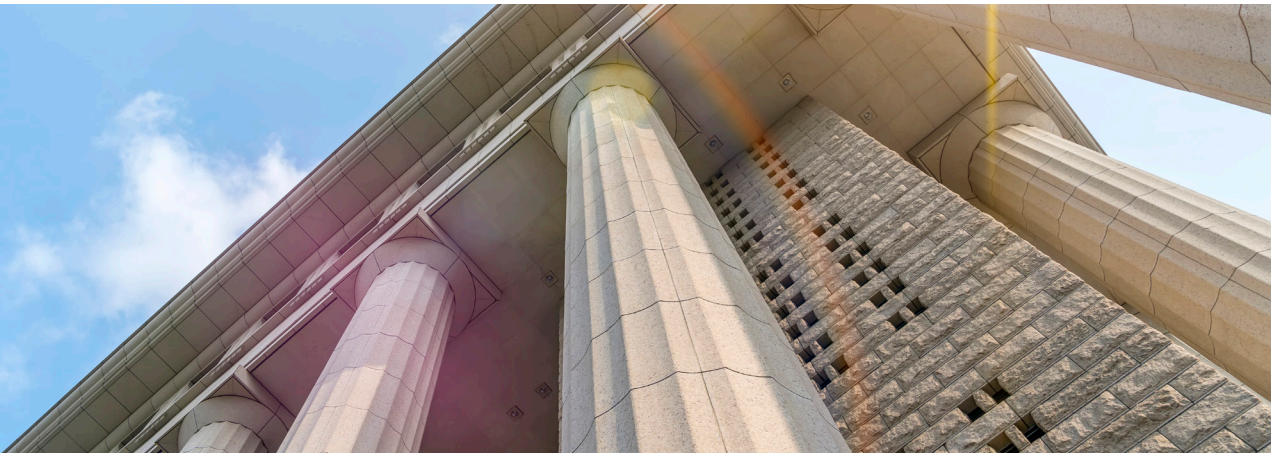

# Preparing for Court Hearings with Luminance Discovery

Recently, leading London barristers' chambers, The 36 Group, used Luminance in advance of a high-profile and historic murder trial. An investigating team of 20 people, including forensic experts, former police officers, solicitors and barristers needed to review over 10,000 documents in order to decide the defence argument and evidence ahead of the murder trial. Previously, The 36 Group had relied on using the Crown Court Digital Case System (CCDS), a web-based platform used to access, prepare and present information for court proceedings. The defence team soon became aware, however, that the CCDS was unable to cope with the complexities and data volume of their current case.

The 36 Group chose to use Luminance, which with rapid cloud deployment, an intuitive interface and advanced project management and collaboration tools ensured that despite working remotely, the 20-person team were able to easily and securely access all of the documents.

By incorporating a unique blend of supervised and unsupervised machine learning algorithms, Luminance is able to instantly read and form an understanding of the documents, which gave the team an immediate and graphic visualisation of their entire dataset. ensured compliance in relevancy coding behaviour across all team members. Using Luminance, the team saw vast-time savings.
