



## Using Luminance to comply with data protection laws

Many companies across the globe are faced with new data protection compliance requirements as governments implement regulations to protect consumers and their information. The General Data Protection Regulation ("GDPR") has been in place in the European Union since 2018 and regulates the transfer of personal data outside the European Union and European Economic Areas. In fact, a recent decision by the Court of Justice of the European Union has made data transfer from the European Union to the United States much more stringently regulated, often requiring new or redrafted data transfer contracts to be executed. More recently in the United States, California implemented the California Consumer Privacy Act ("CCPA") in 2020. Much like the GDPR, the CCPA is intended to improve privacy rights and consumer protection for residents of California. Every company doing business within California, that meets certain criteria, is subject to these regulations. Numerous other jurisdictions around the world are planning or adopting similar regulations so the demands on organizations will continue to increase.



Areas of focus include determining whether there are data protection clauses or addendums in place under current client and third-party contracts; ascertaining whether those contracts are compliant with these new regulations; and

amending contracts that do not comply with the appropriate regulations. However, given the large and growing volume of documents that must be reviewed, it is imperative that the review be thorough, quick and cost-effective. ## Luminance Diligence: Data Protection



Further, by using flexible machine learning, Luminance is able to actively learn from and adapt to the data it sees, ensuring that the platform can be used to meet a wide range of legal and business needs. As data protection regulations increase in both volume and complexity, lawyers need technology to assist them in reviewing vast datasets (deleted a section here). Failure to maintain compliance with applicable regulations can expose their organizations (or clients) to substantial financial penalties and/or reputational damage.



Recently, the legal team at a multinational American e-commerce corporation used Luminance to assist with an internal data protection compliance review. The lawyers needed to review a document set to ensure data processing clauses or addendums were in place and, if so, to determine the nature of the data sharing and data collecting provisions. Ultimately, they needed to categorize each processing agreement accordingly and ensure compliance with the CCPA. Using Luminance, the team were able to immediately identify 15 different data processing agreements that existed within the dataset, a process that would have taken hours with manual methods. Luminance instantly surfaced data protection provisions in a quarter of the documents, and as the lawyers continued to interact with the platform by tagging key datapoints, Luminance's supervised machine learning was able to understand what the team were looking for, extending this learning across the dataset and highlighting crucial information relating to data sharing and collection.
